## **Terms and Conditions:**

## **Eligibility Criteria:**

- The Bidder's Firm should have existence for minimum period of 5 years. Copy of certificate
  of incorporation / registration certificate of the Firm to be submitted. If the Bidder is a
  distributor / dealer / stockiest, it is mandatory to submit valid authorization certificate
  along with PAN card/ GST certificate.
- 2. The ARC is applicable to supply of items to our Head Office at Puducherry and Field stations at Madurai (Tamil Nadu), Kottayam (Kerala) & Koraput (Odisha) only on FOR basis.
