NOTICE INVITING TENDER

The Director, ICMR-Vector Control Research Centre, Puducherry 605 006 (ICMR-VCRC), invites sealed tenders under Single Bid System from the reputed manufacturers / authorized distributors / dealers / stockiest (who have the current authorization from principal company) for entering into **Annual Rate Contract for laboratory chemicals, consumables, DNA sequencing, synthesis and supply of Primers/probes, oligonucleotides (Annexure-II)** for ICMR-Vector Control Research Centre, Puducherry

Terms and Conditions:

Eligibility Criteria:

1. The Bidder's Firm should have existence for minimum period of 5 years. Copy of certificate of incorporation / registration certificate of the Firm to be submitted. If the Bidder is a distributor / dealer / stockiest, it is mandatory to submit valid authorization certificate along with PAN card/ GST certificate.
2. The ARC is applicable to supply of items to our Head Office at Puducherry and Field stations at Madurai (Tamil Nadu), Kottayam (Kerala) & Koraput (Odisha) only on FOR basis.
3. The bid shall be valid and open for acceptance by the competent authority for a period of 180 days from the date of opening the tender.

Submission of offer:

1. Bidders are required to provide the latest original hard copy of catalogue.
2. It is mandatory to submit the quotes in the same format as per Annexure I and if some category of items is not available, it should be mentioned as **NQ** (Not Quoted) in the

relevant column instead of deletion of such item(s).

3. **Procedure for sealing and marking of bids:** The Tenders / Bids cover must contain Annexure I along with enclosures as desired in tender document and this cover should be sealed and super scribed as "TENDER FOR RATE CONTRACT".
4. Price (% of discount) must be submitted in enclosed in Format only as per **Annexure - II**. The discount offered in percentage (%) on the catalogue price + GST and Freight, Insurance charges, if any, is to be borne by the Supplier.
5. Price (% of discount) quoted should be in Indian Rupees only. Price should be FOR delivery at ICMR-Vector Control Research Centre, Puducherry/ Field stations at Madurai (Tamil Nadu), Kottayam (Kerala) & Koraput (Odisha). Freight, Insurance charges, if any, is to be borne by the Supplier / Distributor. Similarly, shortage, pilferage, damage if any in transit will be the sole responsibility of the Supplier / Distributor. The short / defective supply will have to be replaced by the Supplier / Distributor within 2 weeks of time without any additional cost including freight / insurance charges.
6. Prices charged for the stores supplied under Rate Contract should under no event be higher than lowest prices which the party sells the items of identical description to any other Govt. Organization / Private Organizations during the period of contract.
7. The bid should be complete in all respects and should be duly signed. Each and every page of the tender and **Annexure I** should be signed by the authorized signatory of the firm with seal which would show unconditional acceptance of all the Terms and Conditions of the Tender Document. Incomplete and unsigned bids will not be considered. The Institute shall not be responsible for any postal delay and delay in receipt of the offer. Conditional, unsigned, late & delayed tenders will not be accepted under any circumstances.

Evaluation of Tender:

1. The final acceptance/decision on the tender will be taken after screening the offers by a duly constituted committee at ICMR-VCRC which reserves the right to accept/reject the tender wholly or partially without assigning any reasons thereof.
2. The manufacture / dealer / stockiest / agency /firm/ vendor who have quoted the lowest price for a given item will be selected for that product. In case of more than one agency quoting the same lowest price for a product, ICMR -VCRC reserves the right to place order with the agency who has quoted lowest for maximum number of items.

Award of contract:

1. A panel of bidders/suppliers shall be selected for rate contract.
2. The Rate Contract will be valid for a minimum period of 1 YEAR.
3. Notwithstanding anything specified in this tender The Director, ICMR-VCRC in his sole discretion, unconditionally or without having to assign any reason
 - (i) To accept OR reject lowest tender or any other tender or all the tenders
 - (ii) To accept any tender in full or in part
 - (iii) To reject the tender, offer not confirming to the tender norms
 - (iv) To give purchase preference wherever applicable as per Govt. Policy/Guidelines.
4. reserves the right to enter into parallel Rate Contract for similar items during the period of Rate Contract with one or more parties.

Delivery schedule:

1. The supplies have to be delivered in suitable conditions within a period of 20 days from the receipt of the Purchase Order either directly or through dealer (No deviation will be accepted in this regard). Early deliveries by the supplier / distributor would be appreciated. If the ordered material is not supplied within the above mentioned period, then the Director, ICMR-VCRC reserves the right to cancel the order.
2. The supplies will have to be of desired quality and grade. During the inspection/test, if supplies are found to be of inferior quality / inefficacy, the same has to be replaced by supplier / distributor at their cost within the stipulated period, failing which the Rate Contract of the firm shall be cancelled.

General:

1. A concessional certificate for claiming GST @ 5% will be provided against DSIR certificate available with VCRC in terms of Govt. notification 45/2017 – Central Tax (rates) for the chemicals and labwares being used for research purpose.
2. Supplies should be made from the latest batch of production with maximum shelf life and original packing. The material being offered should indicate clearly whether Indigenous manufactured by local registered firm or manufactured by cottage and small scale industries/large scale industries, or Articles wholly or partially manufactured in India from imported materials.
3. Communication with bidders will be carried out electronically and /or in hard copy. All bidders must provide their current email address with document of address proof.

Payment terms:

1. The bill / tax invoice should be raised in the name of “the Director, ICMR-VCRC, Puducherry”. Payment will be made in electronic mode only after satisfactory report from the end Users. No bill for part payment will normally be entertained. No payment will be made for unsatisfactory supply.

2. No advance payment will be given. Being a Govt. of India Organization, payment will be released by way of RTGS after satisfactory supply of goods.

Taxes and duties:

1. This Institute is exempted from payment of customs duty/GST in terms of Government Notification No.51/96-Customs dated 23.07.1996 and Central Excise duty exemption in terms of Notification No.10/97-Central Excise dated 01.03.1997 vide letter No. TU/V/RG-CDE (253)/2011 dated 07/10/2011 valid up to 31.08.2021 as amended from time to time. Therefore, quotation must be submitted accordingly. Necessary documents under this notification will be provided by the Institute, whenever required.
2. Payment of sales tax / GST is primarily the responsibility of the seller and will not be paid unless the percentage value is clearly mentioned in the tender. If no indication regarding CST/GST/ST is recorded in the tender, the CST/GST/ST will be considered as included.
