- The candidates shall bring the duly filled application forms (s) along with all documents in support of (a) Proof of Date of Birth (b) Qualification (c) Experience (d) Recent passport size photograph etc. while coming for written test/personal discussion/interview as per the schedule given.
 Separate Application Form should be filled for each post.

- 3. Mere fulfilling of the essential qualification does not guarantee for the selection.
- 4. Walk-in-Interview and/or a Written test if the number of eligible candidates are more than 30. Negative marks are applicable for wrong answers in the written test.
- 5. Only eligible candidates will be allowed to appear for written test/interview.

Other Terms and Conditions: -

- 1. Qualifications should be from recognized Institutions/Universities only.
- 2. Experience certificate should clearly state the nature of work during the period of employment. Experience in the relevant discipline/ field should be from a reputed institution/ organization recognized by the relevant authority.
- 3. Age relaxation will be admissible in respect of SC/ST/OBC candidates, Departmental Candidates (including projects) and Ex-servicemen etc. in accordance with the instructions issued by the Central Government/DoPT/ICMR from time to time. Age concession to the extent of service rendered in other research projects will also be admissible for experienced and skilled persons. SC/ST/OBC will be given age relaxation in respect of the posts reserved for them only and not for UR posts.
- 4. The Director, ICMR-VCRC reserves the right to increase or decrease the number of posts or cancel the recruitment or re-advertise the posts at any time, without assigning any reasons thereof. No correspondence will be entertained in this regard.
- 5. Date of Walk-in-Interview and or Written test may be changed due to administrative reasons. Hence, candidates are advised to check the website regularly.
- 6. Canvassing in any form for short listing, interview and employment will be a disqualification and such candidates will be barred from selection process.
- 7. **POST QUALIFICATION EXPERIENCE** i.e. experience from the date of completion of minimum essential educational qualification shall only be counted.
- 8. Submission of incorrect or false information shall disqualify the candidate at any stage.
- 9. Since the posts are purely on temporary basis, no benefit of Provident Fund, Leave Travel Concession, Medical, etc. will be available to the appointee.
- 10. The above posts are to be filled-up on purely temporary and contractual basis & the candidates shall have no right to claim for any type of permanent employment or continuation of their services in ICMR-VCRC or in any other project.
